WITH ITS FOCUS ON COLLECTING AWARD NOMINATED SCRIPTS, THE LIBRARY SERVES AS A VALUABLE RESOURCE TO THE COMMUNITY AND ADVANCES THE RECOGNITION OF WRITERS' UNIQUE CONTRIBUTION TO THE ART OF FILM AND TELEVISION.
